Balanced Exposure to Sectors with 18 Rydex Sector Funds

Many sector funds use a traditional market-cap weighted approach, but this can lead to domination by a few large companies and can be problematic in sectors that contain too few stocks. Rydex takes a different approach to sector investing: a modified cap-weighted approach, which seeks to capture the influences of both larger-and smaller cap-weighted companies, not just the largest companies in the sector. Rydex's modified cap-weighted approach, which, in general, takes the square root of each company's market capitalization, acts as a midpoint between these cap-weighting and equal weighting, allowing the market leaders to retain the most influence without unduly dominating the sector and negatively impacting diversification. In a modified cap-weighted approach, where stocks are generally more equally distributed, smaller companies can have more influence over the fund's performance, while larger companies will still remain powerful performance drivers.

Rydex's modified cap-weighted sector funds may help investors take advantage of a broad market rally by giving them exposure to a range of market capitalizations. The potential benefits of this approach include the ability to:

- Exploit market opportunities by offering more balanced exposure to both the larger and smaller stocks within the sector
- Potentially capture larger-cap influences without ignoring the smaller-cap stocks that sometimes outperform large-cap stocks
- Provide the opportunity to outperform during broad market rallies by offering exposure to a range of market caps
