#### S&P 500 Ex-Health Care Index

- Provides exposure to the companies of the S&P 500 with the exception of those included in the health care sector
- Like the S&P 500, uses S&P's Global Industry Classification Standard ("S&P GICS") to define companies within a sector
- Each GICS sector comprises multiple industries, e.g., the health care sector includes companies in, among others, the health care provider, services, and technology industries
- S&P 500's selection criteria includes liquidity, price, market capitalization and financial viability
- Each security is market-cap weighted according to the same rules as the S&P 500
- Portion represented by the excluded sector is redistributed among the remaining companies in the S&P 500 on a pro rata basis
- Follows S&P 500's rules-based guidelines for rebalancing
