
- Focuses on S&P 500<sup>®</sup> companies, except those in the financials and real estate sectors

The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. SPXN was rated against the following numbers of U.S.-domiciled Large Blend funds for the following time periods: 1223 for the last three years and 1116 for the last five years, ending 12/31/22. With respect to these Large Blend funds, SPXN received a Morningstar Rating of 4 stars for the three-year period and 4 stars for the five-year period.
