# Fund description


The Invesco S&P 500 Value With Momentum ETF (Fund) is based on the S&P 500<sup>®</sup> High Momentum Value Index (Index). The Fund will invest at least 90% of its total assets in securities that comprise the Index. The Index tracks the performance of stocks in the S&P 500<sup>®</sup> Index that have the highest value and momentum score. Constituents are selected through a two-step process: first, the 200 stocks from the S&P 500 Index with the highest value scores are identified; second, from among those 200 stocks, 100 securities stocks with the highest positive momentum scores are identified. The index is constituted of these 100 stocks, weighted by their value score. The Fund and the Index are rebalanced and reconstituted semi-annually.



Intraday NAV is a symbol representing estimated fair value based on the most recent intraday price of underlying assets.

Weighted Harmonic Average Stock Price-to-Book-Value Ratio (P/B Ratio) is the ratio of a stock's market price to a company's net asset value.

Weighted Harmonic Average Stock Price-to-Earnings Ratio (P/E Ratio) is the share price divided by earnings per share. It is measured on a 12-month trailing basis.

Weighted Average Return on Equity is net income divided by net worth.
