- >> The Nasdaq Riskalyze US Small Cap Index™ is a modified market capitalization weighted index which seeks to provide a diversified portfolio of dividend-paying US small cap securities.
- >> To be eligible for inclusion in the index, a security must meet certain criteria, including:
 - being a member of the Nasdaq US 700 Small Cap Index,
 - having paid a dividend in the trailing twelve months.
- >> Sector weights are assigned that are equal to the sector weights within the Nasdaq US 700 Small Cap Index.
- >> Securities within each sector are equally weighted.
- >> The index is rebalanced and reconstituted on a quarterly basis.

Unlike mutual funds, shares of the fund may only be redeemed directly from a fund by authorized participants in very large creation/redemption units. If a fund's authorized participants are unable to proceed with creation/redemption orders and no other authorized participant is able to step forward to create or redeem, fund shares may trade at a premium or discount to a fund's net asset value and possibly face delisting and the bid/ask spread may widen.

The COVID-19 global pandemic and the ensuing policies enacted by governments and central banks have caused and may continue to cause significant volatility and uncertainty in global financial markets. While the U.S. has resumed "reasonably" normal business activity, many countries continue to impose lockdown measures. Additionally, there is no guarantee that vaccines will be effective against emerging variants of the disease.
