The investment objective of the World Core Equity Portfolio is to achieve long-term capital appreciation.

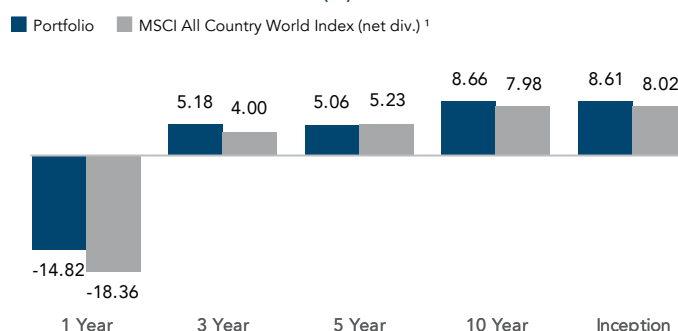
