Prior to 7.11.2011, the fund sought to provide investment results that matched, before fees and expenses, the performance for the S&P DTI. Therefore, the performance and average annual total returns shown for periods prior to 1.29.2013 may have differed had the fund's current investment objective and principal investment strategy been in effect during those periods.
