

The agreement to limit the fund's total annual operating expenses is limited to the fund's direct operating expenses and, therefore, does not apply to Acquired Fund Fees and Expenses (AFFE), which are indirect expenses incurred by the fund through its investments in the underlying funds. This figure may differ from that presented in the Fund's shareholder report.
- ² Morningstar proprietary ratings reflect historical risk-adjusted performance. For each fund with at least a 3-year history, Morningstar calculates a Morningstar Rating™ based on a Morningstar risk-adjusted return measure that accounts for variation in a fund's monthly performance (including the effects of sales charges, loads and redemption fees), placing more emphasis on downward variations and rewarding consistent performance. (Each share class is counted as a fraction of 1 fund within this scale and rated separately, which may cause slight variations in the distribution percentages).
