

Sharpe Ratio is a risk-adjusted measure calculated by using standard deviation and excess return to determine reward per unit of risk. Tracking Error is the difference between the price behavior of a fund and the price behavior of a benchmark. P/B Ratio is the ratio of the fund's market price to the most recently reported book value for the prior fiscal year.
