- Large-cap growth equity.
- Employs a passively managed, full-replication strategy.
- The fund remains fully invested.
- Low expenses minimize net tracking error.

About the benchmark

- The Russell 1000 Growth Index measures the performance of the large-cap growth segment of the U.S. equity universe.
- It includes those Russell 1000 companies with higher price-to-book ratios and higher forecasted and historical growth values.

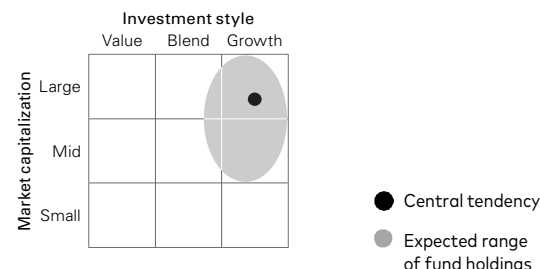

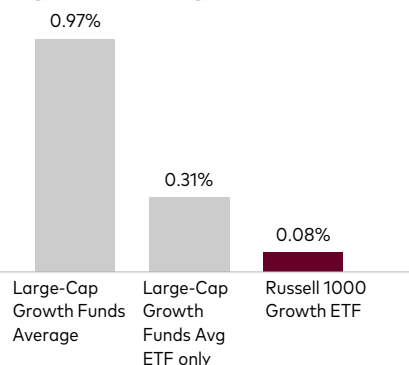
