



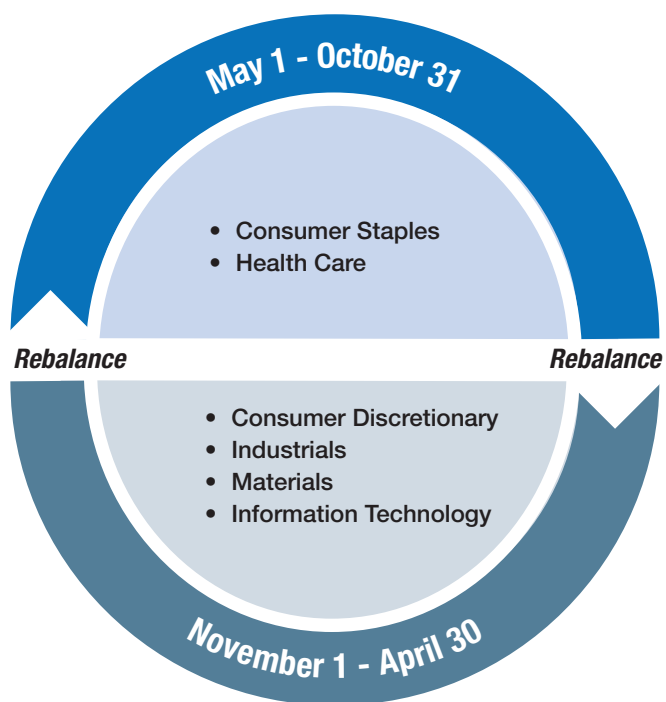

An objective, rules-based strategy that rotates between six sectors semi-annually based on seasonal sector strength.

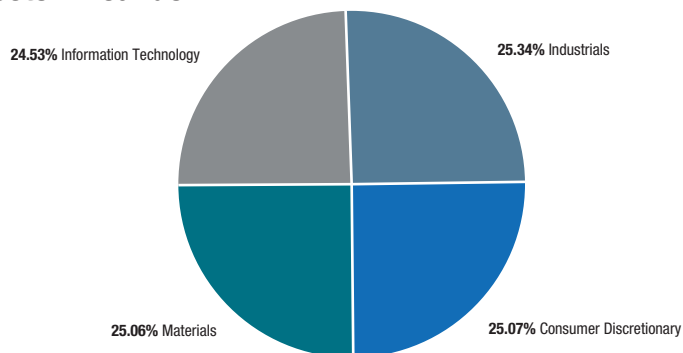
