Net cash to equity is the ratio of a company's cash on hand against the total net worth of the company. R squared measures how well an investment's returns correlate to an index. An R squared of 1.00 means the portfolio performance is 100% correlated to the index's, whereas a low r-squared means that the portfolio performance is less correlated to the index's. Return on invested capital (ROIC) represents the performance ratio measuring a company's percentage return on its invested capital. Sales growth 3 year forward CAGR is the compound annual growth rate of sales from 2022 to 2025 based on FactSet consensus estimates. Weighted average market capitalization is an average of the market capitalization of stocks held by a portfolio or comprising an index, adjusted by each stock's corresponding weight in the portfolio or index.
