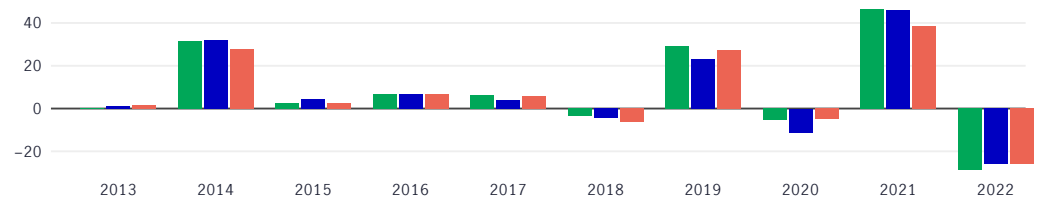

Class I without sales charge

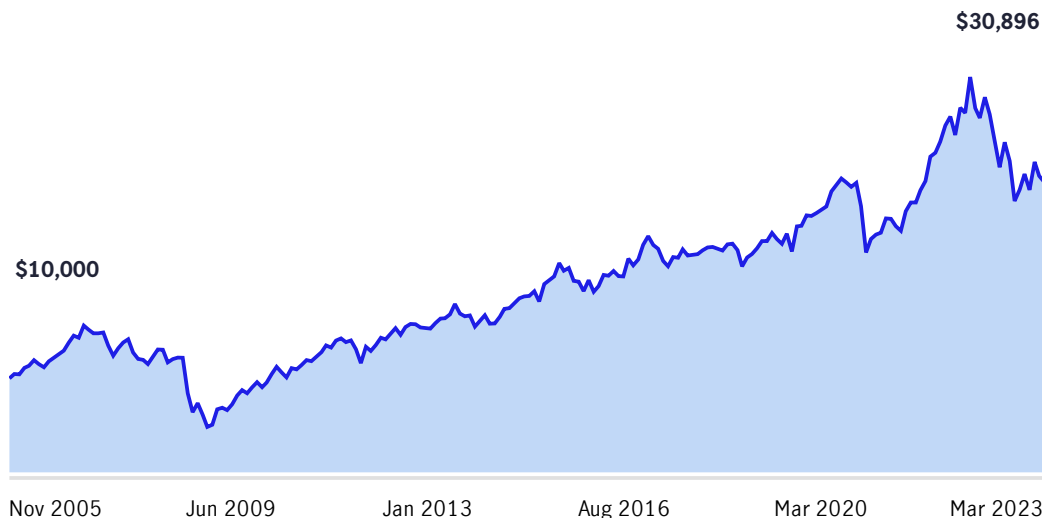

Class I without sales charge – 11/1/05 – 3/31/23



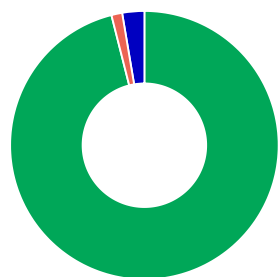
