# **Companies, Not Countries**

The locally-based ~25 person team builds the portfolio one company at a time by looking for stocks in local markets that are trading at a discount, but have the potential to generate strong returns, stocks that may be overlooked by managers operating solely within their home countries. This allows them to focus on the merits of each investment rather than country or sector allocation, seeking to deliver strong outperformance through stock selection.

### **ESG Focus**

The Fund uses a proprietary framework to identify and invest in a selective portfolio of companies that satisfy the Fund's Environmental, Social and Governance (ESG) criteria. By incorporating ESG criteria and an active ownership approach, the Fund seeks to manage risk from an ESG perspective and invest in sustainable businesses trading at attractive valuations that may generate excess returns over the benchmark.

# **Exposure to Opportunities Beyond the Index**

Emerging markets benchmarks can be restricting, as they may have a bias towards larger-cap, government-owned stocks. We believe our broader opportunity set, outside the index, with exposure to small/ mid caps, may offer greater potential for appreciation due to market inefficiencies.



The Goldman Sachs ESG Emerging Markets Equity Fund invests primarily in a diversified portfolio of equity investments in emerging country issuers that the Investment Adviser believes adhere to the Fund's environmental, social and governance ("ESG") criteria. The Fund's adherence to its ESG criteria and the application of the Investment Adviser's supplemental ESG analysis may affect the Fund's performance relative to similar funds that do not adhere to such criteria or apply such analysis. The Fund's investments are subject to market risk, which means that the value of the securities in which it invests may go up or down in response to the prospects of individual companies, particular sectors or governments and/or general economic conditions.
