Faton Vance Growth Fund

The Fund: Fund managers take a long-term view, focusing on purchasing strong franchise companies with above-average growth prospects at attractive price points. The Fund's emphasis on diversification and valuation sensitivity helps make it a core holding for investors seeking the benefits of growth-oriented companies.

The Approach: The managers follow time-tested principles of investing, adhering to a bottom-up investment process grounded in fundamental research, coupled with risk management techniques. Each stock that makes its way into the Fund is evaluated in the context of risk versus reward.

The Features: Growth-at-a-reasonable price philosophy provides investors access to the long-term appreciation potential that accompanies growth investing, yet brings a valuation discipline to a historically volatile style. We believe this approach may enhance long-term return potential and provide a buffer when markets decline.



DEFINITIONS: The Average market capitalization of the companies that have issued the common stocks owned by a Fund. Market Cap is determined by multiplying the price of a share of a company's common stock by the number of shares outstanding. **Beta** is a measure of the relative volatility of a security or portfolio to the market's upward or downward movements. Ratings: The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. While the 10year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
