Since Inception returns for Class C shares for periods longer than 10 years reflect the performance of Class A shares after the deemed 10-year conversion to Class A shares within such periods. Class R6 shares have no sales charge and are available to certain qualified retirement plans and other investors as set forth in the statement of additional information.

Glossary

Beta is a measure of the volatility of a portfolio relative to the overall market. P/E ratio of a stock is calculated by dividing the current price of the stock by its forecasted 12 months' earnings per share. The average of the price/earnings ratio of a fund is a weighted harmonic average of all the current P/E ratios (excluding negatives) of the stocks in the Fund's portfolio. Standard deviation is a statistical measure of the historical volatility of a mutual fund or portfolio; the higher the number the greater the risk. Weighted average market capitalization is the portfolio-weighted mean capitalizations of all equity securities.
