Fund Information

Began operations: June 17, 1999

Objective: The fund's investment objective is long-term capital appreciation.

Distinguishing characteristics: This strategy seeks broad exposure to emerging markets opportunities, principally by investing in emerging markets companies as well as multinational companies with material emerging markets exposure. It also includes a relatively small opportunistic sleeve of emerging markets fixed income with attractive total return potential. Over the longterm, this strategy may have the potential to help provide emerging markets-like returns with developed markets-like volatility.

Types of investments: Common stocks and other equity-type securities, corporate and government bonds, and cash and equivalents.

Non-U.S. holdings: The fund will invest at least 35% of assets in securities of issuers based in qualified developing countries.
