The investment objective of the World ex U.S. Core Equity Portfolio is to achieve long-term capital appreciation.

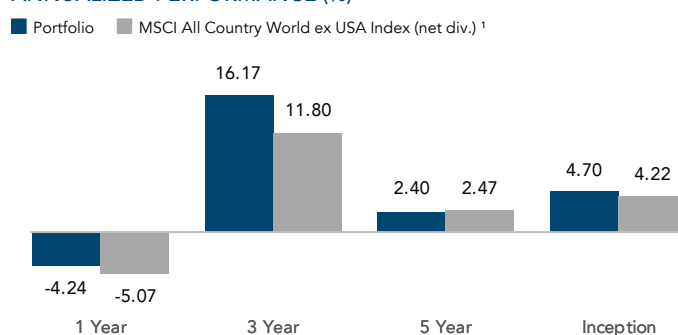
