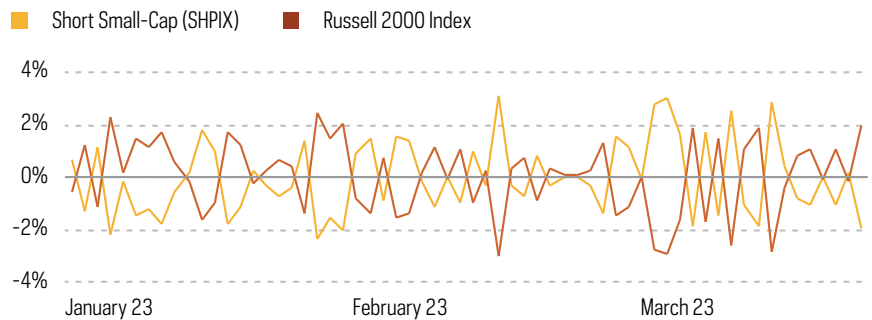

## Daily return during 1Q 2023


