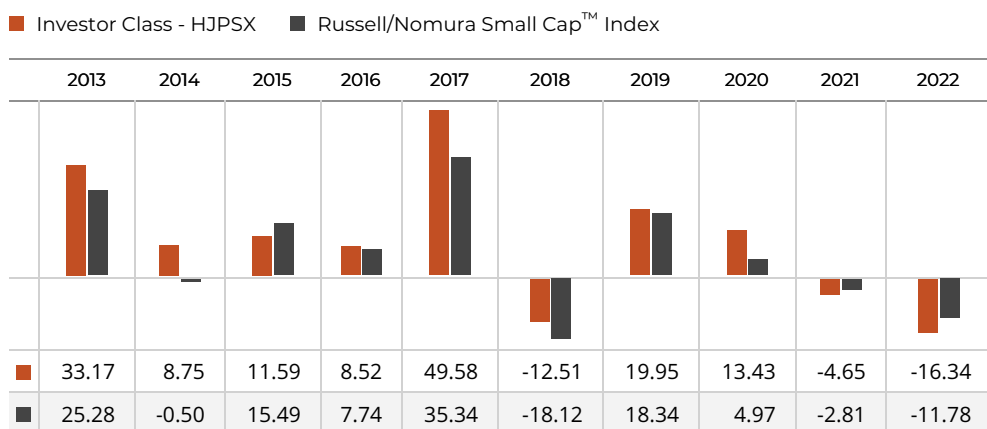
## OVERVIEW

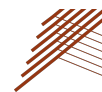
