We believe a diversified international American Depositary Receipts (ADRs) portfolio may achieve long-term returns through capital appreciation, dividend income, and management of downside risk.

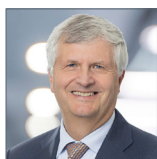
Investment Strategy

- Initial equal weight positions.
- Applies stringent risk screens and controls.
- Seeks broad diversification across countries, sectors, industries and companies.

- Focuses on underperformance risk as much as outperformance opportunity.

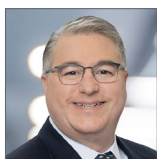

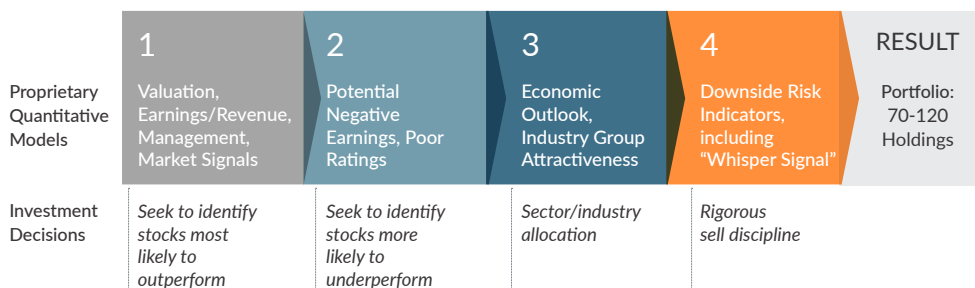
