- Maximum sector exposure is 30%


#### **Market Capitalization**

It is a subjective evaluation performed by Morningstar's manager research group, which consists of various Morningstar, Inc. subsidiaries ("Manager Research Group"). Active Share measures the difference between portfolio holdings and the benchmark. The higher the active share, the greater the risk. Relative to the Russell 2500 Index. Standard Deviation measures the volatility of a portfolio's returns. Beta measures a portfolio's sensitivity to market movements. Sharpe Ratio is the measure of risk-adjusted return of an investment portfolio. Alpha is the excess return of an investment relative to the index's return. R-squared represents the percentage of a portfolio's movements that can be explained by general market movements. Up/Down Capture Ratio is used to evaluate how well a portfolio performed relative to an index during periods when that index has risen/dropped. Statistics for periods less than one year are not annualized.
