Fund Highlights

- The Mirova Global Sustainable Equity Fund is a high conviction all-cap global equity strategy focused on integrating sustainability, with the goal of outperforming the MSCI World Index.
- The managers take a thematic approach, investing in companies that should benefit from their exposure to long-term trends shaping the economy over the next decade across demographic, environmental, technological and governance transitions
- A strict buy and sell discipline focused on fundamental quality, sustainability, and valuation leads to a low turnover, high active share portfolio of ~40-60 names
- Aims to maximize exposure to companies with positive impact on the UN Sustainable Development Goals ('SDGs') and maintain coherence with a 2°C global warming scenario
- Draws on the expertise of Mirova's multi-disciplinary investment specialists with complementary backgrounds and Mirova's ESG Research Team, fully dedicated to thematic and ESG research

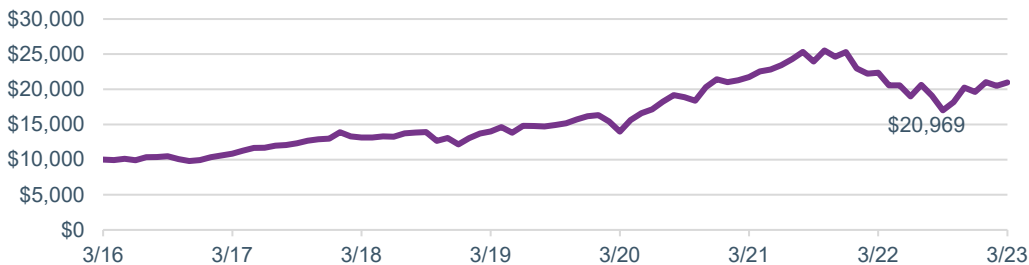

It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly excess performance, without any adjustments for loads (frontend, deferred, or redemption fees), placing more emphasis on downward variations and rewarding consistent performance. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star (each share class is counted as a fraction of one fund within this scale and rated separately, which may cause slight variations in the distribution percentages).
