

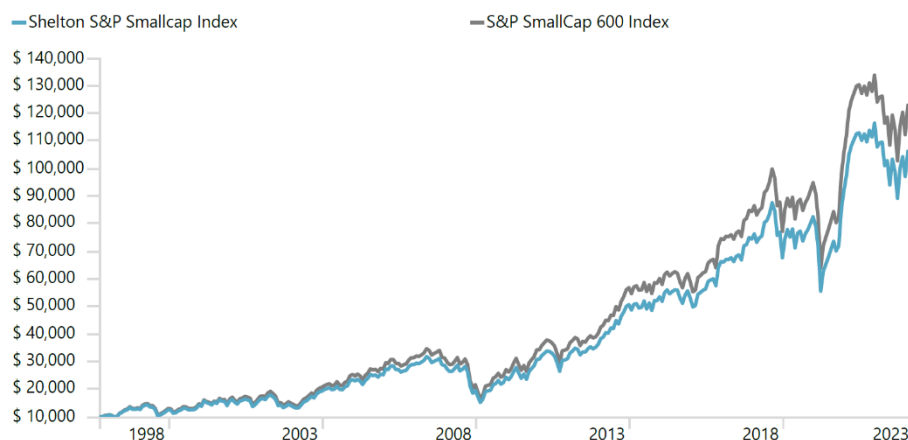
Fund Objective
