Fund Objective

The State Street International Stock Selection Fund (the "Fund") seeks to provide long-term capital growth by investing primarily in securities of foreign issuers.

The Adviser employs a proprietary quantitative multi-factor stock-selection model to select securities while controlling risk exposure of the Fund relative to the Fund's benchmark.

Process

The Fund will attempt to meet its objective through the active selection of equity securities. The Fund management team will concentrate investments in holdings that are composed of, but not limited to, countries included in the Morgan Stanley Capital International Europe, Australasia, Far East (MSCI® EAFE®) Index. The Fund's Adviser employs a proprietary quantitative multi-factor stock selection model. This model is intended to reflect the risk characteristics of the Fund's benchmark, as well as determine the specific securities and quantities the Fund purchases, holds and sells. The quantitative model allows the Adviser to evaluate each eligible security and then rank eligible securities in the Fund's investment universe in the order of their attractiveness as Fund investments. The Adviser also regularly reexamines the model and may make updates and adjustments to the economic and financial conditions and other quantitative metrics considered, and to the weightings among them.


