Fund description


The Invesco S&P 500 Minimum Variance ETF (Fund) is based on the S&P 500[®] Minimum Volatility Index (Index). The fund will invest at least 90% of its total assets in securities that comprise the index. The index employs a managed-volatility methodology that seeks to achieve lower total risk than the S&P 500 Index, while maintaining similar characteristics. Volatility is a statistical measurement of the magnitude of up and down asset price fluctuations over time. The fund and the index are rebalanced and reconstituted semiannually.



30 Day SEC Yield is based on a 30-day period and is computed by dividing the net investment income per

share earned during the period by the maximum offering price per share on the last day of the period.

Intraday NAV is a symbol representing estimated fair value based on the most recent intraday price of underlying assets.

Weighted Harmonic Average Stock Price-to-Book-Value Ratio (P/B Ratio) is the ratio of a stock's market 16.54 11.92 price to a company's net asset value.
