Direxion Daily Financial Bull and Bear 3X Shares

Overview

The <u>Direxion Daily Financial Bull and Bear 3X Shares</u> seek daily investment results, before fees and expenses, of 300%, or 300% of the inverse (or opposite), of the performance of the Financial Select Sector Index. There is no guarantee the funds will meet their stated investment objective.

These leveraged ETFs seek a return that are 300% or -300% of the return of their benchmark index *for a single day*. The funds should not be expected to provide three times or negative three times the return of the benchmark's cumulative return for periods greater than a day.

Target Index

The Financial Select Sector Index (IXMTR) is provided by S&P Dow Jones Indices and includes securities of companies from the following industries: Banks; Thrifts & Mortgage Finance; Diversified Financial Services; Consumer Finance; Capital Markets; Insurance; and Mortgage Real Estate Investment Trusts (REITs). *One cannot directly invest in an index*.

Under the Operating Expense Limitation Agreement, Rafferty has contractually agreed to waive all or a portion of its management fee and/or reimburse the Funds for Other Expenses through September 1, 2024, to the extent that a Fund's Total Annual Fund Operating Expenses exceed 0.95% of the Fund's average daily net assets (excluding, as applicable, among other expenses, taxes, swap financing and related costs, acquired fund fees and expenses, dividends or interest on short positions, other interest expenses, brokerage commissions and extraordinary expenses). If these expenses were included, the expense ratio would be higher.
