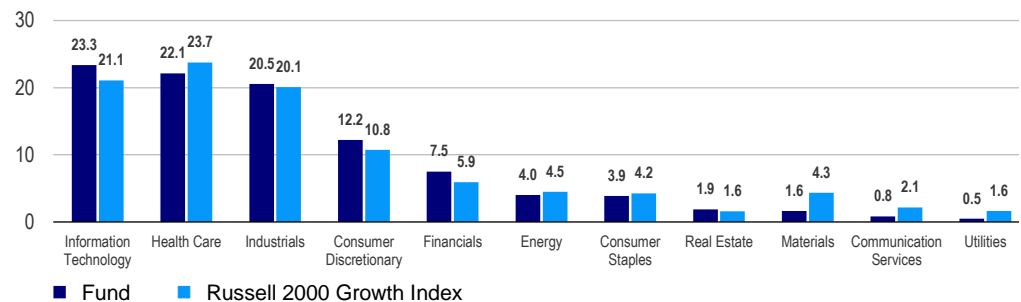

The fund offers investors exposure to high-quality US small-cap growth equities and seeks to outperform the benchmark with less volatility over a full market cycle.

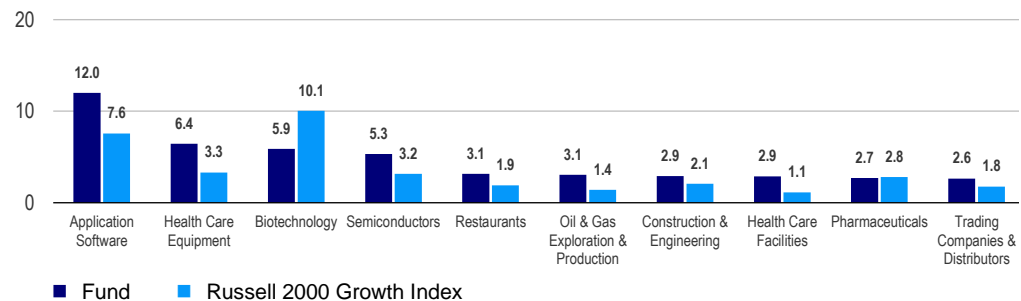

## Sector breakdown (% of total net assets)



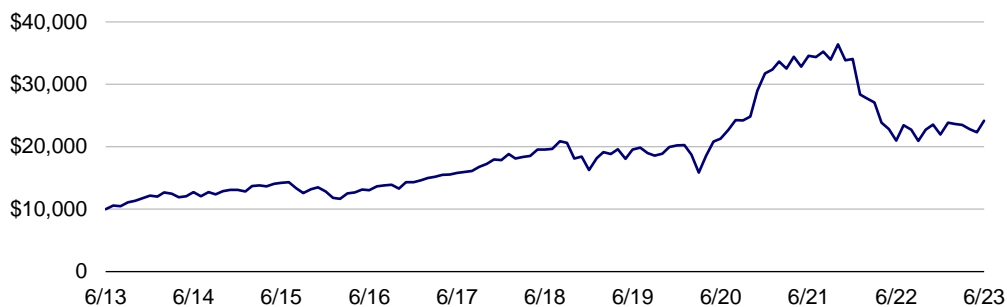
## Top industries (% of total net assets)

A higher Sharpe ratio indicates better risk-adjusted performance. **Standard deviation** measures a fund's range of total returns and identifies the spread of a fund's short-term fluctuations. **Tracking Error** is defined as the expected standard deviation of a portfolio's excess return over the benchmark index return. The **up and down capture** measures how well a manager was able to replicate or improve on periods of positive benchmark returns and how severely the manager was affected by periods of negative benchmark returns.
