Fund Information

Began operations: March 26, 1993

Objective: The fund's investment objective is to provide long-term growth of capital while providing current income.

Distinguishing characteristics: This strategy has the flexibility to seek growth and income opportunities around the world. It invests primarily in seasoned companies, including those paying regular dividends and those with attractive growth prospects. This diverse strategy may have the potential to provide low volatility as well as downside protection.

Types of investments: Primarily common stocks, government and corporate bonds, and cash and equivalents.

Portfolio restrictions: May invest up to 10% of assets in bonds rated BBB+/Baa1 or below.

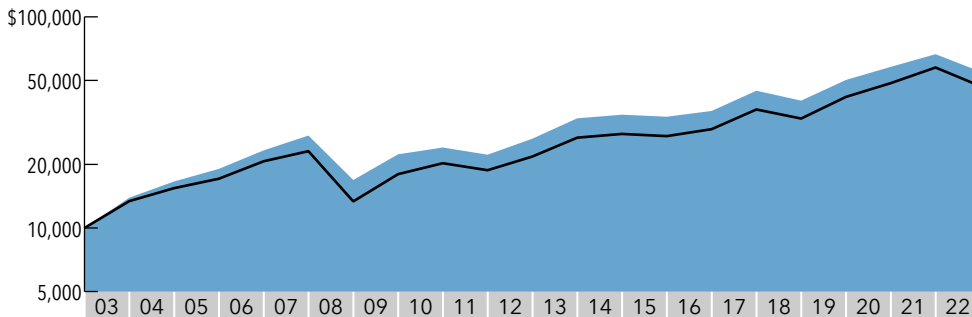

MSCI breaks out each company's reported revenues into country-by-country estimates. MSCI provides revenue data figures based on a proprietary, standardized model. Revenue exposure at the portfolio and index level was calculated by using FactSet, which takes these company revenue exposures and multiplies by the company's weighting in the portfolio and index. In this breakdown, Israel has been included in Europe.

Capital World Growth and Income Fund Historical Benchmarks Index: Capital World Growth and Income Fund Historical Benchmarks Index returns reflect the results of the MSCI World Index through 11/30/2011 and the MSCI All Country World Index, the fund's current primary benchmark, thereafter.
