The Fund seeks to provide long-term capital appreciation by investing in a diversified portfolio of companies with market capitalizations of \$1 billion and above. The team's investment approach is designed to achieve consistent long-term returns across the full breadth of market conditions and economic cycles. The focus of its investment process is on security selection and risk management.

About the Fund

- The Fund's investment style focuses on companies that we believe are high-quality with the potential for above-average earnings growth, as well as current earnings momentum.
- Specific characteristics sought include: companies with 8 up quarters and/or 5 up years of EPS growth; stable to rising earnings per share growth; high stability of earnings; superior financial strength; attractive valuation versus peer group; favorable technical indicators.





Active Share is a measure that compares the proportion of security holdings within the product against those of the respective benchmark. The value represents the percentage difference between fund and benchmark. **Market Capitalization** is the total dollar value of all

outstanding shares computed as number of shares times current market price. **Alpha** is the excess return of a fund relative to the return of a benchmark index. **Beta** is a measure of the volatility, or systematic risk, of a security or portfolio relative to the market or a benchmark. **R-squared** is a statistical measure that represents the percentage of a fund's or security's movements that can be explained by movements in a benchmark index. **Standard Deviation** measures an investment's historical volatility, calculated using the investment's annual rate of return. **Portfolio Turnover Ratio – LTM** measures trading activity in a portfolio for the past year, indicating how often investments are bought and sold. **Average Price/Earnings (P/E) Ratio** is the current share price of a stock divided by its earnings per share.

The **Russell 3000® Index** is a market-capitalization-weighted index that measures the performance of the 3,000 largest U.S. stocks by market capitalization and covers 98% of the investable U.S. equity universe.
